



Inspiring Educators FAQ

Question: Who is eligible to receive funding?

Answer: Educators who are currently employed as a teacher or other certified employee in an accredited K-12 public school or accredited K-12 public charter school located in the Bullhead, Fort Mohave, Mohave Valley, Laughlin, Topock, and Needles areas. Substitutes, paraprofessionals, and other support roles are not eligible for funding.

Question: Where do I go to apply?

Answer: Please click on the link titled "Inspiring Educators Application" to go to the application. The link will direct you to SurveyMonkey for you to submit your application.

Question: How long is the application?

Answer: The application should take you about 15-20 minutes to complete. We want detailed yet concise answers that give a big picture of what you want to accomplish with the funding.

Question: When is the submission timeframe?

Answer: The application will be open from December 15th (8 am) through January 10th (5 pm). The review period will occur the week of January 12th. Awardees will be invited to an Inspiring breakfast to announce the winners to be held on January 31st.

Question: How will the winners be selected?

Answer: A committee comprised of BHHS Legacy Foundation staff, board members, and community partners will review the applications and score them against a matrix. The matrix consists of four criteria: application supports BHHS Legacy Foundation focus areas, proposed items are unique/effective, clear impact on students, and inspiration is evident and clearly stated.

Question: How much are the grants?

Answer: The top educator will receive \$2,500, the runner-up will receive \$1,500, and 36 support prizes at \$500 will be given.

Question: What is the process for accepting the grant?

Answer: We will invite all selected educators to an Inspiring Breakfast to be held on January 31st, where the winning amounts will be revealed. The week of February 2nd, BHHS Legacy Foundation will send a grant agreement letter for electronic signature. Upon sending the fully executed grant agreement, please submit your Amazon wishlist to: kwilliams@bhhslegacy.org that reflects the amount awarded. The wish list will be due to Foundation staff no later than May 1st.

Question: What are the expectations if I am awarded the grant?

Answer: Educators will be required to sign a grant agreement. Educators are encouraged to submit a thank-you letter for the funding. Educators are required to submit their Amazon wishlist for fulfillment by BHHS Legacy Foundation staff. Educators must submit a final report that includes photographs of the program/project. The link to submit the final report along with the deadline will be sent out early May. Failure to submit a final report will make the educator ineligible for future grants.

Question: Are after-school or extracurricular programs accepted?

Answer: Programs/projects must take place during school hours within the school day to qualify for funding.

Question: What are the terms and conditions of the funding?

Answer: Please click on the link titled "FAQ" to review the terms and conditions.

Question: What happens if I move schools after receiving the grant?

Answer: The grant funding will remain with the educator if they are in BHHS Legacy Foundation geographic approved area; otherwise, the educator will forfeit the funding, and it will be reallocated. Further, if you are selected to receive a grant, the funding and resulting items will remain at the school listed in your application.
