



Inspiring Educators Terms & Conditions

BHHS Legacy Foundation Inspiring Educators is limited to educators currently employed as teachers, school administrators, or other certified employee in an accredited K-12 public school or accredited K-12 public charter school located in the Bullhead, Fort Mohave, Mohave Valley, Laughlin, Topock, and Needles areas. A qualifying school may have multiple educators submit an application. Each educator may only submit one application.

BHHS Legacy Foundation Inspiring Educators program will award 38 educators with grant funding to support their classrooms. The program will utilize a committee to rank applications based on set criteria. The matrix consists of four criteria: application supports BHHS Legacy Foundation focus areas, proposed items are unique/effective, clear impact on students, and inspiration is evident and clearly stated. Winners will be announced on April 20th at an Inspiring breakfast.

If selected to receive a grant, funding will be facilitated through Amazon utilizing their wishlist feature. BHHS Legacy Foundation staff will purchase approved items and send them to the school on behalf of the educator. Winners will not receive a check or cash.
